9. Important information:

- 9.1 The registration, accreditation, administration and provision of PSiRA Training course material (Grade E-C) or (Grade B-A) is payable on submission of the relevant application.
- 9.2 Applicants for the above mentioned categories may apply for grade courses packed as follows:
- Option 1 : Grade E to C
 - Option 2: Grade B to A
 - Option 3: Grade E to A
- 9.3 For the purpose of upgrade for existing security service training providers it is compulsory to obtain the PSiRA course material for the existing / current courses as per the initial accreditation.
- 9.4 The administration fees illustrated above must be consolidated, pending the number of classrooms and capacity of students per classroom. These fees are payable subsequent to the inspection for the purpose of accreditation.
- 9.5 These fees are **NOT** payable with immediate effect. The Authority will announce the application of this fee which will be relevant in the implementation of the PSiRA online assessment.
