

FINANCIAL AID FOR TVET LEARNERS 2022/2023

The Private Security Industry Regulatory Authority (PSiRA) invites applicants from the South African Private Security Industry to apply for Financial Aid towards study fees of security officers' legal children who are accepted to study at TVET colleges across South Africa. The Financial Aid is for the 2023 Academic year and is part of the PSiRA Corporate Social Investment (CSI) in the Security Sector. **The closing date for applications is 17 February 2023.**

Applying for the Financial Aid

PSiRA will pay study fees for the successful application enrolled to study at TVET, with a legal parent registered with PSiRA as a security officer and actively working at the same employer for the last three years. Financial Aid will be awarded to learners who reside within the following regions:

Application Requirements:

- The application must be submitted through the learner's legal parent's security company, referencing their PSiRA registration number.
- The PSiRA registration status of the parent or legal guardian must be up to date.



- Certified ID copies of the legal parent and learner must be submitted with the application.
- The parent and learner must be South African.
- The learner must be 18 to 35 years of Age.
- Learners must have completed Grade 12 and be enrolled or accepted to register with TVET college.
- Financial Aid is offered for the duration of 18 months full-time.
- The maximum cost per learner is up to R12 000.00 for the awarded academic year.
- The Financial Aid will not be offered to learners who are funded by any other bursary scheme.

The implementation of this financial Aid will enable PSiRA to continue supporting access to higher education and training of children of security officers.
