ULCG SUMMIT,

Durban International Convention Centre 11-15 November 2019

Summit remains the most anticipated meeting of
Local and Regional Leaders and decision makers. The event
brings together over three thousand (3000) representatives of towns,
cities, metropolitans and regions, the business world and academia from around the
world to interact with their counterparts from across the globe.

PSiRA exhibited at the UCLG Summit from the 11th to the 15th of November 2019. The exhibition took place at the Durban Exhibition Centre. Councillors, Mayors, Speakers of Municipalities from the Eastern Cape, Northern Cape, Limpopo, Gauteng and Free State provinces, visited stand to ge more knowledge on PSiRA and how it would add value municipalities. Interest from municipalities was tantamount and resulted in some municipalities inviting the regulator to meetings at their respective provinces.

PSiRA delegates attended the African Forum for Urban Safety (AFUS) learning exchange sessions where issues such as "How to advance gender equality at the local level" were discussed. The Speaker of the Ethekwini Municipality Ms. Weziwe Thusi attended these discussions. South Africa was applauded for its transformation in relation to women having strategic roles in government and other entities. Other African countries sought the best practices of South Africa when it came to gender equality and requested assistance in implementing these best practices.

On the second day of the summit, the PSiRA delegates attended the second segment of the AFUS learning exchange sessions. Discussions on the second day focused on the prevalence of sexual abuse in African countries where there are wars. The Democratic Republic of Congo's delegate facilitated the discussion and the country is a victim to these injustices towards women. Homage was also paid to Doctor Denis Mukwege, a Congolese gynaecologist who was awarded a Nobel Prize for his ability to repair through reconstructive surgery the horrific damage inflicted on women who have been raped. Discussions on this issue also focused on the reporting process and ensuring that women receive the justice they deserve.

Under the theme of Local Policies and Voices was a session on 'Building Safe Public space" wherein there were discussions about the protection of the municipal facilities (for example recreational facilities) and the people who make use of those facilities. The discussions went further to the escalating rate of criminal activities within public spaces. After the presentation by the MMC of community safety in the City of Johannesburg, Hloniphani Xulu indicated the importance of private security industry as a stakeholder in ensuring safety and security in public spaces.

The PSiRA delegates also attended a "Global conversation Towards a Local Inclusion for Migrants and Refugees Action Tool (LIAT)" which was led by the UN-Habitat, Migration policy group, and the International Organization for Migration (IOM). The aim of the session was to develop mechanisms integrating in a peaceful and harmonious manner the integration of migrants in the cities.

The Research unit gave a presentation at the PSiRA stand on what PSiRA is about on Thursday the 14th of November 2019 to a crowd of thirty people. The presentation covered the research publications that were conducted by the Authority. This engagement session with respective dignitaries from around the world, enabled for thorough engagement on what the regulator does and how other countries especially in the African continent can use PSiRA as a benchmark. In the deliberations, it was also highlighted that close protectors, car guards (parking marshals), special events security officers and other security service providers used by local government and municipalities have to do a security training and be registered with PSiRA for them to render any security services.

Platforms like the UCLG Summit is able to showcase the cities to the world and PSiRA has been able to be part of the world stage.

The awards are a stepping-stone for both security company owners and the employees enabling them to reach greater heights in their field of work, even when facing challenges, which in some occasions cost them their lives bearing in mind their mandate of serving the society.

The Private Security Industry Regulatory Authority (PSiRA) has embarked upon changing the norms and standards of capturing course reports from Training centres.

Course reports were solely captured at head office, whereby training centred would courier the respective reports to PSiRA at their preferred time. PSiRA has looked into the process of receiving and capturing course reports.

Training centres now need to provide PSiRA with course reports, strictly within five days, after students have completed their courses. Should training centres delay to provide PSiRA with the necessary reports they will be subjected to a penalty.

The call has also been headed to no longer centralize capturing of course reports at Head office but to allow the process to take place in branches as with, effective from the 23rd of September 2019. This will allow for training centres to drop off and pay for the course reports at any of our branches, where we will have dedicated consultants solely capturing course reports.

This will reduce the turnaround time for students to be captured on our system and to register with PSiRA.

The Private Security Industry Regulatory Authority (PSiRA) was established in terms of Section 2 of Act 56 of 2001 to effectively regulate the private security industry and to exercise effective control over the practice of the occupation of security service providers in the public and national interest and in the interest of the private security industry itself.





The Law Enforcement division has been involved in many operations in the past three months. There have been thirteen thousand and seventy two (13072) inspections nationally, throughout the country with most of them being in the Gauteng province.

Operations are at times conducted with our stakeholders, namely: South African Police Service (SAPS), Department of Employment and Labour and The Department of Home Affairs. Collaborating with these stakeholders has proven that by working together, we are more capable of holding those accountable at a faster pace.

Compliance & Enforcement is a major factor in operations and at times will lead to arrests, with two hundred and nine (209) arrests of unregistered Security officers of which one hundred and twenty-nine (129) of those being arrested are identified as foreign nationals.

As much as the Authority encourages consumers, security officers and businesses to report improper conduct, there were only four hundred and sixty nine (469) improper code of conduct dockets opened. Two hundred and fifty three (253) were against small businesses, eighty five (85) were against medium businesses and one hundred and thirty one (131) were against big business. This raises a concern as to whether if there is a fear to report a matter by members, as some are working within the industry and are fearful of losing their jobs.

The Authority also receives cases which are related to the Private Security Provident Fund (PSSPF), which deal mostly with non-payment of members contributions over to the Fund, companies not contributing to the Provident. There have been six thousand nine hundred and twenty one (6 921) cased reported and finalised.

Private Security Industrial Regulatory Authority (PSIRA) is ready to launch a new customer service system at the head offices in Centurion Pretoria. This system is set to regulate the queuing system and to make customers service more advanced.

Introducing the Que Management System (QMS)

The Que management system is made to fasten customer services, this is one of the first system will be launched on the 3rd of December 2019, it was highly recommended after having to deal with the receptionist to call the consultants and inform them about a client that needs assistance. With the introduction of this system, PSIRA is determined that it will make things easy for both the customer and the consultant.

Customers will be required to report to the reception as they arrive in our offices and the receptionist will issue out a Que management ticket, they will then be directed to relevant waiting areas and wait for their Que number to be called and that's where they will be assisted by a consultant after it has been called.

This system will manage and monitor customer inflow and it is planned to be introduced in other regions in the near future, all customers are required to use the new system as it is to help them find solution to their inquiries.
