**SUBJECT: BASIC REGISTRATION FEES FOR TRAINING SERVICE PROVIDERS**

1. Subsequent to the industry Circular issued on **29 June 2018**, the Authority hereby informs you that all interested security service providers wishing to apply for PSiRA accreditation are encouraged to submit as from as from 15<sup>th</sup> August 2018.
2. The Private Security Industry Regulatory Authority (PSiRA) has determined the following fee structure for registration and accreditation in the following categories of security service providers:

### **2.2.1 New applications:**

A once-off application fee of Fourteen Thousand Three Hundred (**R14 300.00**) for a security service provider registration, as provided for in sections 4 (k) and 23 of the PSiR Act for SSPs offering Grades E-C.

### **2.2.2 Existing security service providers (non-training sectors):**

A once-off charged fee of Eleven Thousand Three Hundred and Fifty Rand (**R11 350.00**) payable by registered security service providers already registered with PSiRA who want to offer Grades E-C.

### **Additional ranch registration applications:**

A once-off fee of Fourteen Thousand Three Hundred **(R14 300.00)** payable by security service providers in good standing who seek to register satellites offices. If a branch is already registered, the fee will be **R11 350.00** for an SSP offering Grades E-C and Eleven Thousand Seven Hundred **(R11 700)** for Grades B-A.

#### **2.3.4 Non-accredited training service providers:**

A fee of Eleven Thousand Three Hundred and Fifty Rand **(R11 350.00)** is payable by security training service providers who want to offer Grades E-C.

### **3. Administrative fees**

These fees will be charged in the second phase of the accreditation. This will be subsequent to accreditation inspection. Admin fees are determined by the number of classes and capacity of students per classroom that the security training provider wishes to cater for. Note: maximum of 30 students per class.

### **4. Transactional fees:**

These are minimal standard fees applicable to both accredited security service provider and student security officer.
